The 40-member coalition has drafted its own proposed state and federal legislation to set best practices guidelines, in the belief that tax resolution practitioners should meet set standards, increasing transparency and requiring certification and continuing education for all companies and individuals in the [tax debt resolution](#) field. The TPRSC will also respond to media inquiries and work to provide redress for consumers who have been victims of fraud.

Rozbruch hopes that the efforts of TPRSC will not only instruct consumers on how to spot a tax debt relief scam but will also turn a spotlight on the many positive and important services that experienced and legitimate tax-resolution firms such as TRS have to offer. "What many people don't realize is that TPRSC member firms provide the American consumer an invaluable service that goes beyond just negotiating payment plans, penalty removal, and [Offers in Compromise](#)," he said. "We are a voice, an advocate, a mediator for the consumer who is the David about to face Goliath in a showdown."
