This timely interview highlights the fact that currently [IRS tax issues](#) effect 1 out of 6 Americans including many who have been hurt by poor economic conditions for the very first time - often through no fault of their own. These same effected consumers may forget to take care of such fiduciary responsibilities as filing tax returns and paying back taxes eventually winding up on the wrong side of the IRS.

Founder and CEO, of Tax Resolution Services, Michael Rozbruch shares how people often find themselves in this situation. "People fail to file required tax returns for a number of reasons. The first reason is that they don't have the money to pay the balance due with the return so they figure if they don't have the money, they just aren't going to file – huge mistake. Others reasons (people don't file) are death or serious illness of a loved one or loss of a job – in other words, life altering events that put the filing of taxes on the back burner."

When a consumer finally decides to get help with their IRS tax problems, according to the IRS tax experts at Tax Resolution Services, it's generally with 4-11 unfiled tax returns along with a certified collection letter from the IRS, or recent contact by an IRS agent. Taxpayers in this situation are encouraged to hire a [Certified Tax Resolution Specialist](#) or [tax attorney](#) expert in handling IRS tax debt problems and who can safeguard their clients against IRS powers of intimidation.

"What people may not realize is that by filing a tax return late, penalties incurred from that oversight can be up to 25% of the taxes owed", states Brian Compton, President of Tax Resolution Services, Co. "Another thing people don't realize is that penalties can be forgiven if they have reasonable cause such as natural disaster, business failure of the death of a family member" says Compton.

A certified tax resolution specialist plays an advocate role for their clients and focuses on education, transparency and client services. They thoroughly analyze and represent each client's case to the IRS and seek the most cost effective means for [tax debt resolution](#) that save both individuals and businesses money.
